The CLUB, ATHLITIKI ENOSI LEMESOU (AEL), informs you that on Friday the 25th of May 2018 it officially started implementing the new Regulation on the Protection of Personal Data (GDPR), which was approved in April 2016.

In view of harmonizing with GDPR, we would like to inform you that only the absolutely necessary data needed for the operation of the register of athletes of the club (Name and Surname, Date of Birth, Contact Number, Identification Number, Email Address and Postal Address) are kept in our database. The management and protection of your personal data are subjected to the terms specified in the privacy policy as this appears in the official website as well as the offices of the club. We also respect the relevant provisions of the European General Data Protection Regulation 2016/679 “GDPR”.

The CLUB, ATHLITIKI ENOSI LEMESOU, (AEL), takes into serious consideration the protection of your personal data and aims at providing a safe use of its services. It is committed to respecting the provisions of the regulation on the protection of personal data. The company takes all measures for safeguarding the process of receiving personal data to secure the right to be informed and the right of access, as these are provided in the European Regulation.

Taking into account the provisions of the European Regulation, we confirm that the processing of data is confidential and is conducted exclusively and solely by persons who are under the control of the data protection officer and only upon his instructions and who have been chosen by the data protection officer, on the basis of relevant professional qualifications as well as technical knowledge and personal integrity in order to provide sufficient guarantees for confidentiality.

We further confirm that the data protection officer takes appropriate organizational and technical measures, for the safety of the data and their protection from random or unlawful destruction, random loss, corruption, prohibited transmission or access and every other form of unlawful processing, pursuant to the European Regulation.

The CLUB, ATHLITIKI ENOSI LEMESOU, (AEL), informs you that access can be provided to the personal data which are of your concern, to a physical or legal person who provides services to the CLUB and/or allowances and/or offers or acts upon our directions or for or on our behalf as well as to an employee or other officer of that person (either in Cyprus or abroad) for any reasonable purpose in the context of carrying out our works or exercising or promoting our services or operation.

In any event, all necessary safety measures for the preservation of your data are taken. We store in electronic or any other form, one or more files of personal data, in which the personal data related to you are registered and which have been declared or will be declared by you to us and for which you retain the right of access anytime, upon a relevant application to the club.
